THE PROBLEM — WHY AUSTRALIANS CANNOT GET AHEAD

HOUSING · RENT · MORTGAGES

Sydney median house \$1.4M. Rents up 40% in 3 years — 38 consecutive months of increases. Mortgage repayments 50% of median income. Every RBA rate rise transfers \$2,000+/month from borrowers to bank shareholders. The housing crisis is the cost-of-living crisis.

POWER · GROCERIES · FUEL · GP

Power bills among the highest in the developed world. Woolworths and Coles take 400-500% markup over farmgate. Bulk billing collapsed — \$80 gap fees per GP visit. Two oil refineries left in Australia. 28 days fuel reserve. Every basic cost is too high.

WAGES · JOBS · BUSINESS · WELFARE

Real wages falling 3 consecutive years. Wage theft treated as civil not criminal. BAS compliance costs \$1,200-\$3,200/yr just to lodge. Starting a business takes weeks. JobSeeker \$54/day — below rent in any city. Childcare consumes the entire second income.

THE MMP SOLUTION

\$50K TAX-FREE — DAY ONE

First \$50,000 tax-free for every Australian. Save \$6,717/yr at \$60K · \$9,967 at \$100K · \$13,717 at \$150K. The single most direct cost-of-living measure available: your money, not taken.

POWER PRICES LEGISLATED — 15c/kWh

Maximum 15c/kWh for households and small business — legislated end of first term. SBC corridor grid delivers industrial power at 6c/kWh. Coal closes as market outcome. Power bills fall. Not promised — legislated.

SUPERMARKET DUOPOLY — AI MONITORING

ACCC with divestiture powers. Mandatory code — criminal penalties. AI 1-million-product dashboard tracks farmgate-to-shelf margins in real time. Middleman extraction flagged and published within 24 hours. Farmers paid fairly. Families pay less.

BULK BILLING RESTORED — \$0 GP

Medicare rebates restored to 95% of AMA fee for regional bulk billing. \$0 to see a GP. 10 free psychology sessions per year per person. No means test. No gap. A family in Farrer or Broken Hill sees a doctor without paying.

FUEL SOVEREIGNTY — PRICES PUBLISHED

Live fuel prices on the People's Portal — cheapest servo near you before you leave home. Fuel tax credits permanent for farmers. 90-day strategic reserve on Australian soil. Biofuel mandate 10% by Year 4. Micro-refinery network regional.

CHILDCARE CAPPED — \$10/HOUR

\$10/hr childcare cap. Provider subsidies make it viable. The poverty trap ends. Second income goes to the family. 26 weeks parental leave — 8 weeks each parent, non-transferable. Time and money. Both matter.

RENT CAPPED · MORTGAGE RELIEF

Annual rent increases capped at CPI + 1%. Emergency rental assistance triggers if median rent exceeds 35% of regional income. Fresh Start mortgage restructure for households in genuine distress — independent mediator, binding on the bank.

WAGES PROTECTED · BUSINESS UNLEASHED

Wage theft criminal — not civil. Minimum wage indexed to inflation automatically. BAS abolished. Business registered in 24 hours. Zero tax first 3 years. 80% Commonwealth loan guarantee. Founders Programme: 100,000 places — welfare to business.

FISCAL POLICY ATTACKS INFLATION

MMP attacks inflation at source — not by raising interest rates and punishing borrowers. Power prices legislated down. Food margins AI-monitored and capped. Housing supply expanded via SBC. Inflation falls because things cost less — not because incomes are squeezed.

CORRIDOR TOWNS — \$150/WEEK RENT

181 corridor towns. Rent \$150/wk. Power \$0. Commute \$0. A corridor family is \$70,000/yr better off than Sydney. As the interior becomes liveable, coastal price monopoly ends. Land prices fall where people actually need to live.

WELFARE FLOOR — 65% OF MINIMUM WAGE

JobSeeker from \$54/day to ~\$85/day. Indexed to wages, not CPI. Rent Assistance raised to 40% of actual median regional rent. Insurance reinsurance pool for flood, cyclone, bushfire zones. Cash access legislated as a right.

CITIZEN DIVIDEND — FROM YEAR 5

REL revenues + SBC corridor revenues → Sovereign Wealth Fund. Every Australian adult: \$400-600/yr tax-free from Year 5, growing. Not welfare. A return on the resources that belong to everyone. Norway built \$1.7 trillion. We build ours from the sun.
